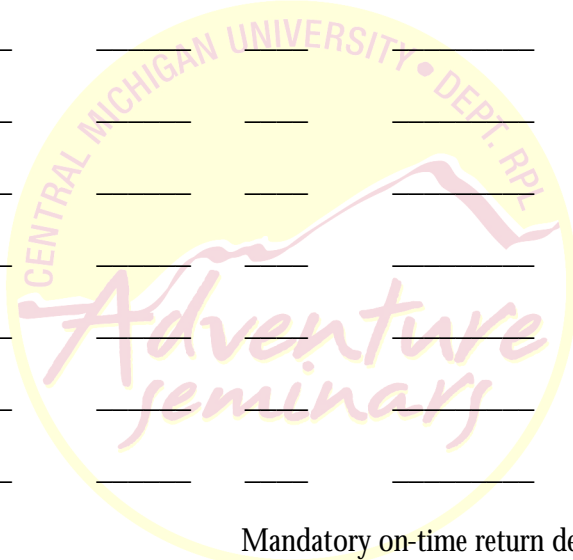

I also assume cost to fix or replace any damaged gear that I rent and realize that the \$10 on-time return deposit and \$10 cleaning deposit will both be returned to me so long as the equipment is returned on time and clean.

1. In consideration of benefits received, the renter hereby assumes all risks of damage, to either person or property, which may be sustained by the renter or others while using the rented equipment.
2. The renter may not assign this agreement of sublet or lend any rental equipment without the express written consent of RPL's Adventure Seminars, which consent may be withheld for any reason.
3. The renter realizes that there are potential risks, hazards and dangers inherent in the use of outdoor rental equipment and that the said equipment should only be used in those activities for which the user has the prerequisite skills, qualifications, preparation and training.
4. Adventure Seminars makes no warranties, either express or implied, as to any matter whatsoever, including, without limitation, the construction, condition, merchantability or adequacy of any rental equipment for any type use or its fitness for any particular purpose.
5. Reservations for equipment can be made up to two weeks in advance. All payments must be made in full at this time with the understanding that there will be no refunds unless cancellation occurs within three days of the rental check-out date, at which time 10% of the total cost will be kept for a cancellation fee. Renters will be assessed a fine to their student account, at current retail prices, for *lost* or *damaged* equipment.
6. Equipment can only be returned at posted times unless prior arrangements have been made. The \$10 gear return deposit will be forfeited if the gear is returned late.
7. The \$10 cleaning deposit will be forfeited for all gear returned dirty or wet.
8. Payment is required in full prior to renting gear, unless otherwise determined by the Adventure Seminars Staff.
